Commissioner Tovey made a motion to approve Ordinance #24-11-1: An ordinance providing for the issue of \$312,763 General Obligation Limited Tax Park Bonds, Series 2024, of the district for the payment of land condemned or purchased for parks, for the building, maintaining, improving and protecting of the same and the existing land and facilities of the District and to provide the revenue source for the payment of certain outstanding bonds of the District, providing for the levy of a direct annual tax to pay the principal and interest on said bonds, and authorizing the sale of said bonds to Wheaton Bank & Trust Company, N.A.; seconded by Commissioner Berntsen.
